

## **Terms and Conditions**

### *AIC National Conference 2019 ('Promotion')*

1. The Promotion is conducted by Sympli Australia Pty Ltd ABN 43 624 341 420 of Level 16, 130 Pitt Street, Sydney, New South Wales 2000 ('Promoter').
2. By entering the Promotion, entrants accept these terms and conditions.
3. Entrants must satisfy the following criteria to be eligible to enter the Promotion:
  - i. the entrant must be at least 18 years of age or over; and
  - ii. the entrant must not be an employee or contractor of the Promoter.
4. Entry to the Promotion opens on 11 April 2019 at 8.45am AEST and closes on 23 April 2019 at 12:00pm AEST ('Promotion Period').
5. To enter the Promotion, the entrant must, during the Promotion Period:
  - i. answer the question in the comments on our social media post asking for entries to this competition on either Facebook LinkedIn or Twitter: "Tell us why you think Sympli is a force of positive change for the industry?" using 25 words or less; and
